However, new members are eligible for voting. In case, the candidates gets less than 1/6th of the total votes polled, the security deposit shall be forfeited. 
SPECIAL NOTE

COUNTING OF VOTES


The counting will start immediately after polling is over and result will be declared immediately after completion of the counting.
